**Department of Ecology News Release - July 23, 2003****03-150****Ecology Department penalties total \$356,287 in second quarter of 2003**

OLYMPIA - Following is a summary of all penalties of \$1,000 or more issued by the Department of Ecology during the second quarter (April, May, June) of 2003, which totaled \$356,287. All together, Ecology has issued \$650,837 in penalties this year.
